

ORDERS BY CHAIRPERSON, PUNJAB SCHOOL EDUCATION BOARD

1. As per Article 16 and 17 of Punjab School Education Board Act 1969, amended Act, 1987, 2000 and 2005, Sacred Heart Convent Senior Secondary School, Chak Attar Singh wala (Bathinda) is granted provisional affiliation for Senior Secondary (Science and Commerce) standard for year 2014-2015.

2. The institution shall admit students only for 11th (science and commerce) class for the year 2014-2015 w.e.f. 1-4-2014

3. i) The institute is allowed one section of 50 students for +2 Science group/+2 commerce group

This provisional affiliation is subject to the following conditions:-

1. The institute shall comply with the Affiliation Rules and amendments made thereto from time to time, minutely.

2. The institution shall pay by September 15, of the preceding year, shall submit annual progress report (as per Annexure B proforma alongwith documents) alongwith the prescribed fee, in this office. In case of extension of affiliation from year to year, the institute shall be bound to deposit the extension fee alongwith progress report this year i.e. upto 15/9/2014.

3. The violation of the rules, at any stage, shall be taken seriously and action shall be taken against the institution in accordance with rules

4. The institute, shall allow the prescribed books as per board syllabus by the Board and also shall charge fee from students in accordance with rules.

5. The institute shall abide by the traffic rules as per decision in case Namit Kumar Vs. Chandigarh Administration and others' by Hon'ble Punjab & Haryana High Court and Supreme court in letter and spirit

6. The institute shall pay to his teaching staff, the salary at least of preliminary of minimum Govt. scales through Account Payee's cheque in accordance with Affiliation Rules 2000

7. Shall abide by all the conditions on the reserve page

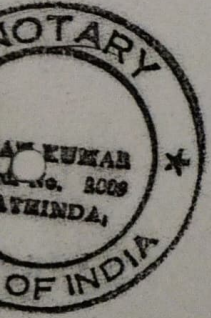
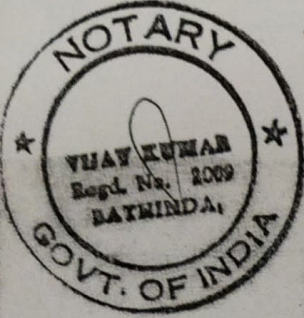

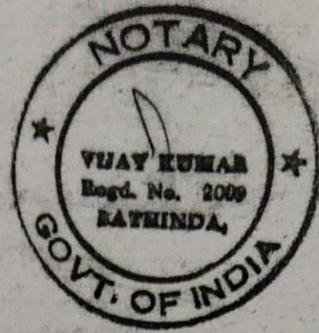
